Introduction

1

The regulatory requirements of MiFIDII/MiFIR apply with effect from 2 January 2018. According to this, all trading participants who pursue a market making strategy in at least one instrument on the Xetra trading platform are required to register as regulated Market Maker on the Frankfurt Stock Exchange and are obliged to fulfil the minimum requirements as stipulated by Frankfurt Stock Exchange.

In addition, Deutsche Börse offers trading participants the opportunity to register as Designated Sponsor. Designated Sponsors are regulated Market Maker with higher minimum requirements who, in return for the continuous provision of liquidity, are entitled to reimbursement of transaction costs. For further information on the discount offered for regulated Market Maker or Designated Sponsor activities, please refer to the Xetra Price List.

In order to compare the performance of the various Designated Sponsors in equities, Deutsche Börse AG calculates a rating - a kind of seal of approval. The rating includes the average duration of a designated sponsor's quote, average spread and turnover. In addition, the rating can be optionally enhanced by a plus sign "+" when the Designated Sponsor has reaching a predefined passive volume share or "e" in case when Designated Sponsor has registered as Respondent for Xetra EnLight.

Deutsche Börse provides regulated Market Maker and Designated Sponsors with the performance and rating reports described in this document to allow a self-monitoring of their own performance as Market Maker or Designated Sponsor.

The performance reports contain all the measures necessary to meet the minimum requirements, while the rating reports also contain additional criteria for assessing the performance of the Designated Sponsor. Regulated Market Making- as well as Designated Sponsor-Reports are available in. csv format on the Common Report Engine. In addition, Designated Sponsor reports are still available as text files.
